The functions of the Academy shall be-

- 1) To encourage the Urdu language in all its aspects in this State.
- 2) To promote exchange of creative ideas between the State language Marathi and Urdu through translation and other literary pursuits
- 3) To initiate, assist or undertake the implementation of projects or schemes which may further the cause of Urdu.
- 4) To initiate assist, or undertake the publication of papers monographs, books and journals in Urdu.
- 5) To provide financial assistance to writers and poets, residence in Maharashtra, for publication of their literary works, if approved by the board.
- 6) To provide financial assistance to literary societies and Urdu literary activities.
- 7) To initiate, assist or organise seminars, conferences, symposia or exhibitions for the encouragement of Urdu in the State.
- 8) To supply books or magazines to the libraries and public reading rooms.
- 9) To give awards for excellence In Urdu in different literary fields to writers and poets, and resident in the State.
- 10) To give fellowships and /or scholarships to deserving Urdu scholars or students, resident in the state
- 11) To raise resources, funds, donations, and or contributions from the public by such means as may be approved by the State Government and to utilise the same from the activities of the said Academy.
- 12) To keep the State Government informed, from time to time, of the activities of the board, and the needs of the Urdu speaking people.
- 13) To advise Government in formulating its policies in the matter of development of Urdu in the State and in assisting it in their implementation.

The non official members of the above Academy shall be held eligible for travelling allowance and daily allowance as are admissible under scale I in Rule 1 (I) in Appendix XLVI- A (Section I) to the Bombay civil Services Rules Manual, Volume II, as amended from time to time. For the time being the Under Secretary to the Government of Maharashtra, General Administration Department should be authorised to countersign the travelling allowance bills of the non officials, members of the academy.

The expenditure involved in the above proposal should be debited to 268- Art and Culture.

This resolution issues with the concurrence of the Finance Department.


